**Conditions and Terms**

1. Applicant acknowledges that fees for the 45-day reservation reflect normal daily rates as set by the DNR and adopted by City Council. No discounts apply.
2. Current boat registration must be submitted with application. Applications will not be accepted without a current registration.
3. Agreements and invoices will be mailed in early December (Spring Stay) and Mid-January (Fall Stay).
4. A limited number of slips will be available for the Extended Stay Program. If we receive more applications than slips available, all applications will automatically be placed in a lottery and drawn at 1:00 PM on the due dates listed above.
5. If after the agreement is signed and the fee is paid in full, should you cancel your agreement, this is the refund policy: 60 days or more in advance, refund less 10%; less than 60 days in advance, refund less 25%; less than 30 days in advance, no refund. No exceptions.
6. PLEASE NOTE: the 2024 rates were approved by City Council on October 2, 2023.
